STORAGE AND DISPOSAL

Store in the original container in a cool, well ventilated area. Do not store for prolonged periods in direct sunlight. Triple rinse containers before disposal. Add rinsings to the spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. Do not burn empty containers or product.

SAFETY DIRECTIONS

Harmful if swallowed. May cause skin sensitisation by skin contact. Facial skin contact may cause temporary facial numbness. Will irritate the eyes and skin. Avoid contact with eyes and skin. When opening the container, preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist, washable hat, elbow length chemical resistant gloves and face shield. If product on skin,

immediately wash area with soap and water. After use and before eating, drinking or smoking, wash hands, arms, and face thoroughly with soap and water. After each day's use wash gloves, face shield and contaminated clothing.
