Application Method	Target Pest	Instructions
Read-to-Use POUR-ON	Buffalo Fly (<i>Haematobia irritans</i> exigua) and Stable Flies (<i>Culicoides spp.</i>)	Apply the measured dose along the backbone, ensuring that the mane and rump are treated. Do not apply to head or the ears.
Read-to-Use WIPE-ON	Stable Fly (<i>Stomoxys calcitrans</i>)	Wipe legs, shoulders and belly with an applicator mitt/cloth. For the first application with a new applicator mitt/cloth, it is recommended to pre-soak the applicator to charge the mitt/cloth. Store mitt/cloth in a resealable plastic bag.

Repeat treatment as needed but not more often than once every 7 days

Flyscreen™ should be applied using the graduated dispensing chamber incorporated in the container. Loosen the cap and apply measured dose either poured directly on the animal or onto applicator mitt/cloth and then onto the animal.

Apply to horse at the rate of 6 mL per 100 kg body weight, as per the dose table below:
DO NOT apply more than 30 mL per animal.

BODYWEIGHT	DOSE
Up to 100kg	6 mL
101 – 200 kg	12 mL
201 – 300 kg	18 mL
301 – 400 kg	24 mL
401 – 500 kg and above	30 mL

Application: Apply when fly numbers exceed acceptable levels. For dirty horses, shampoo and rinse thoroughly before application. DO NOT apply to horses that will be ridden within 24 hours of application.
